# **Hurricane/Storm Relief**

# a. Discuss additional options for hurricane/storm relief for LMBTs renewing their licenses

The Board discussed its decision made at its regular scheduled Board meeting on October 17, 2025. The Board reviewed information regarding declared disaster counties and agreed their earlier decision did not do enough to assist those LMBTs impacted by the Hurricane Helene and tropical storms. Upon motion made, seconded and passed, the Board agreed to (1) remove the \$75 late renewal fee for renewals submitted after November 1 and on or before December 31; (2) allow LMBTs living in a declared disaster county the ability to renew without their required continuing education hours pursuant to Guideline 2.5; and (3) allow therapists who can demonstrate that their continuing education course was canceled due to the declared disaster to renew without the required continuing education hours. The late renewal fee will still be effective for renewals submitted after December 31, 2024, and any missing hours for their 2024 renewal will be added to their next renewal. Board staff agreed to schedule a meeting with IT to discuss updating the renewal system to conform with the Board's decisions.
